For initial teacher certification eligibility, all of the following is required:

- Successful completion of all course work.
- ❖ Pass required TExES content area exam as indicated above for your degree plan. Areas indicated with a (**) require an additional exam (Science of Teaching Reading) for certification eligibility.
- Pass required TExES pedagogy exam.

- Conferral of Master's Degree. (official awarding of degree)
- Submission of certification application, completion of fingerprinting process, & paid associated fees for both.
- ❖ Pass fingerprint background check/TEA***.

***Texas Education Agency (TEA) requires passing a fingerprint background check for certification issuance. If needed, a person who is enrolled or planning to enroll in a State Board for Educator Certification-approved educator preparation program or planning to take a certification examination may request a preliminary criminal history evaluation letter regarding the person's potential ineligibility for certification due to a conviction or deferred adjudication for a felony or misdemeanor offense. Notices

The semester PRIOR to internship, apply for a job to work as either an intern teacher (a year-long, paid position in charge of your own classroom) or a clinical teacher (a single semester position in a classroom with a teacher). If you choose the clinical teaching path, you will register for 6 hours of clinical teaching for the fall. These hours are not accepted for graduate credit therefore you will be required to take two additional graduate level courses within the teacher preparation coursework.

You are responsible for information about academic standing, course loads, comprehensive examinations, time limitations, campus clearance eligibility, completing degree & certification requirements, state testing, applications/fees, other information in the catalog related to your program. It is the responsibility of program candidates to complete the certification application process within a timely manner upon degree conferral & passing all required certification exams or run the risk of losing passed exam(s) and certification eligibility due to unpredictable changes in state law and rules.
